Learning Agreement and Terms & Conditions of Trip Booking 2017

We're confident you'll find your dive training both fun and rewarding. To learn and practice important concepts and skills for using life-support equipment underwater, you must invest the time needed to do it. This agreement is between you (the student diver) and our instructional staff regarding our mutual responsibilities in this program.

Student Diver Responsibilities

I (student diver) agree to study independently as specified by the instructor. In general, this means that before each practical session, I will:

- Complete the assigned knowledge development portion of the course, including:
 - Read/watch the assigned materials and complete the Quick Quiz questions.
 - Complete the assigned Knowledge Reviews.
 - Complete the Final Exam (as assigned).
- In addition, I agree to:
 - Follow all course procedures as set forth by my instructor.
 - Ask questions about anything not understood.
 - \circ $\,$ Be on time and prepared for each practical session.

If I do not follow the points above, I understand that I may need to reschedule practical sessions and that I'm responsible for any additional costs related to this. Diving Unlimited agrees to give every reasonable consideration to unforeseen events, such as family emergencies.

Instructor/Staff Responsibilities

The course instructor and staff agree to:

- Start the class as scheduled.
- Provide a positive learning environment.
- Answer your questions to the best of our ability.
- Assist you through any course challenges.
- Provide opportunities for as many knowledge development, confined water dives and open water dives as necessary for you to comfortably master course-performance objectives. Because people learn skills at different rates, the course is student-centred and performance-based, not time-based.

Terms & Conditions

- 1. Candidates may not participate in any diving activities without satisfactorily completed PADI medical statement and release forms.
- 2. I understand & agree that the designated Diving Unlimited Dive Officer will have the final say as to who can participate in what dives in respect to training level, physical ability and any predisposing factors to be accounted for prior to said dive. There will be no exceptions.
- 3. All dives, unless satisfactorily planned by those qualified to conduct Decompression Dives, are to be planned and executed as No Decompression Dives. All divers must have a suitable SMB & reel. There are to be no exceptions.

- 4. On receipt of a deposit or booking fee, places will be allocated & booked. The full balance of the trip should be made payable no later than the agreed settlement date for each trip. Delays may result in your allocation being redistributed. The deposit, booking fee or final balance is non-refundable which includes the event where the student diver is unable to attend or complete any of the planned activities for **any** reason. There are no exceptions. It is suggested that relevant insurances be obtained prior to engaging in the event, to cover all costs should the student diver be unable to attend.
- 5. Any person using Diving Unlimited equipment for any course or individual hire are responsible for that equipment and will be charged for any loss or damage arising from negligent use/behaviour at current list prices.
- 6. Should weather or other circumstances beyond the control of Diving Unlimited, including minimum numbers required to run the said trip or course, cause the trip to be delayed, changed or cancelled, no liability can be accepted by Diving Unlimited for consequential loss, damage or expense incurred.

I understand that venues selected by Diving Unlimited may be subject to change at the last minute and that it is my responsibility to organise travel arrangements to and from these venues. Accommodations, although booked by Diving Unlimited, are my responsibility with regard to settlement (unless included in the package price), damage, loss, personal injury or any other incident incurred to or by myself.
